AFFIDAVIT

- I, Mark Rixey, having been duly sworn or affirmed, do hereby depose and say:
 - 1. My name is Mark Rixey. I am over the age of 18 and am of sound mind and body.
 - 2. On April 4, 1989 I was a deputy in the Brevard County Sherriff's Department.
 - 3. My partner Sergeant Diane Clarke and I were the first officers to respond to the orange grove crime scene on the night of the murder. I remember that night clearly.
 - 4. I got the dispatch call at 1:13 a.m. on April 4, 1989. Kim Hallock, who called 911 reporting the possible shooting of Mr. Flynn gave us the wrong location at least twice. She first told us to go to the corner of US 1 and Jay Jay Road. As a result, we did not find Flynn until 1:42 a.m. Eventually Deputy Wade Walker III had to drive to pick up Ms. Hallock at Oak Park Trailer Park, where she went to call 911, to lead us to the correct location.
 - 5. Sergeant Clarke and I found Mr. Flynn alive and lucid. Despite being lucid, when asked several times who shot him, he only responded that he wanted to "go home." He never mentioned any black man or unknown assailant. Mr. Flynn stopped breathing more than once and Clarke resuscitated him.
 - 6. I called the paramedics, but they did not arrive until 15 or 20 minutes later. So much time elapsed because of Ms. Hallock's inconsistent locations. By the time the paramedics arrived, Flynn had stopped breathing for the final time.
 - 7. Seargeant Clarke and I secured the crime scene upon finding Mr. Flynn. It was pitch dark. I could not see my hand in front of my face.
 - 8. When Ms. Hallock was brought to the orange grove crime scene, she was emotionally detached. She did not seem concerned about Mr. Flynn's condition, and did not ask about him even once.
 - 9. The physical evidence at the orange grove crime scene did not match Ms. Hallock's story. Not only did she send us to the wrong grove at first, but she described herself as having sped away from the scene in a frantic hurry. Yet, the tire tracks at the orange grove crime scene were clear and unmarred. Clear and unmarred tire tracks are not consistent with exiting that terrain in a hurry in that type of truck.

- 10. Other suspicious facts were that Ms. Hallock drove all the way to Oak Park Trailer Park, which is more than two miles from the orange grove crime scene, to call for help after supposedly escaping from an armed assailant. Between the orange grove crime scene and the Oak Park Trailer Park, there were numerous houses and public telephones. She could have stopped at any one of these places to call for help for Mr. Flynn, who was lying shot in the grove.
- 11. Earlier on April 3, 1989, I drove through Holder Park around 11 p.m. and I did not see Mr. Flynn's truck. I did not see any person or any cars. My car had alley lights, take-down lights, and a spotlight. There is a chance that I did not see Mr. Flynn's truck, but it is unlikely. If I had seen people or vehicles, I would have stopped them.
- 12. Additional information implicating Ms. Hallock includes the fact that, in her initial statement that was transmitted over the police radio, she never mentioned an abduction. Ms. Hallock changed her story several times that night. One example of this is that she told Deputy Walker, the first BCSO officer to have contact with her, that she tied Mr. Flynn's hands with a shoelace. Later, she stated that the assailant tied Mr. Flynn's hands.
- 13. The morning after Mr. Flynn died, I reported to Officer Thom Fair, who was conducting the homicide investigation, that based upon the evidence that I saw as the first responder on the scene, that Ms. Hallock shot Mr. Flynn. I also reported to Officer Scott Nyquist, another homicide investigator, that the evidence pointed to Ms. Hallock as having shot Mr. Flynn. I also told multiple other people within the BCSO that the evidence pointed to Ms. Hallock. To my knowledge, lead investigators Fair and Nyquist never followed up on this information.
- I was never been approached by any member of Mr. Green's defense team concerning Ms. Hallock killing Flynn until May 2010. After initially telling Fair, Nyquist, and other members of the BCSO that Ms. Hallock killed Flynn in April 1989, I believe that I have only been approached once by a member of law enforcement on this subject. Kent Sellers, a fellow member of the BCSO, asked me about this case once. I told him that Crosley Green is innocent.
